PROFIT WARNING FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2023

This announcement is made by the Company pursuant to Rule 13.09(2)(a) of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform shareholders of the Company and potential investors that, based on the Company's preliminary review of the management accounts of the Group, it is expected that the unaudited profit attributable to equity holders of the Group for the nine months ended 30 September 2023 will decrease by approximately 70% as compared with that of the same period in 2022.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Asia Cement (China) Holdings Corporation (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

The board of directors (the “**Board**”) of the Company wishes to inform shareholders of the Company and potential investors that, based on the Company's preliminary review of the management accounts of the Group, it is expected that the unaudited profit attributable to equity holders of the Group for the nine months ended 30 September 2023 will decrease by approximately 70% as compared with that of the same period in 2022.

The Board considers that the above expected decrease was primarily due to the selling price of the Group's products declined compared with that of the corresponding period of the previous year.

This information contained in this announcement is only based on a preliminary assessment by the Board with reference to the information currently available from the management accounts of the Group, which have not been reviewed or audited by the Company's auditors and are subject to possible adjustments arising from further review. The actual results of the Group for the nine months ended 30 September 2023 may be different from what is disclosed in this announcement.

It is expected that the announcement for the unaudited consolidated results of the Group for the nine months ended 30 September 2023 will be published by the end of October 2023.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
